## BUILDING PERMIT REQUIREMENTS FOR NEW CONSTRUCTION, ADDITIONS AND ACCESSORY STRUCTURES

Incomplete applications are not accepted. 25% of permit fee required at time of application.

1. Residential: Three (3) bound sets of plans drawn to 1/4" = 1.0 foot.

Including:

Foundation plan with details/single story or multi-story

Floor plan showing room uses and dimensions

Elevations

Cross sections of walls.

Roof and floor framing plan.

Detailed Electrical plan to include meter & condenser location

\*Homeowner permits require completion of "Instructions for Permit" and "Responsibilities and Liabilities Acknowledgement"

- 2. Three (3) site plan drawings (please see attached sample drawing)
- 3. Recorded proof of Ownership and Legal access with legal description of property (Warranty Deed or Real Estate Contract) Copy can be obtained at County Clerk's Office Room 200.

  If accessing a county road a driveway permit (\$20.00) may be required from the Engineering Department. If accessing a state road a permit from NMDOT may be required.
- 4. SEPTIC TANK OR SEWER SERVICE (Utility Bills not accepted)

If septic tank bring in a copy of septic tank permit from NMED located at 2301 Entrada Del Sol, Las Cruces, NM (575) 288-2050

If sewer service bring in a letter from the sewer company verifying sewer service is available.

PROOF OF WATER SERVICE (Utility Bills not accepted)

If domestic well bring in a copy of the well permit from NM State Engineer's Office located at 1680 Hickory Loop, Las Cruces, NM (575)524-6161

If water service bring in a letter verifying water service is available from water company provider

- 6. **Copy of truss layout and design from manufacturer (site built NOT allowed).** Roof framing plan shall show truss layout. Truss calculations shall be available at frame inspection.
- 7. **Residential Energy Plan Review:** REScheck, REM Rate or Acca Manual J is required with your permit application. The Manual J must be completed by a licensed HAVC contractor or professional designer.
- 8. **SWPPP and NOI:** Required for (1) All projects located in a subdivision; or (2) Outside a subdivision when the parcel exceeds one acre AND square footage of structure exceeds 21,000 sq. ft. Please verify with DAC Engineering Department for specific requirements or questions. (575) 525-6164
- 9. Electrical, Plumbing, and Mechanical permits are obtained AFTER issuance of the building permit by the licensed tradesman at the Building Inspections Office.
  - \* A homeowner test is available for those who wish to perform their own Electrical or Plumbing. Please inquire.
